NEW BENEFICIAL OWNERS IDENTIFICATION SERVICE

Shareholders Right Directive II (Directive EU 2017/828) has been transposed to Spanish legislation with Law 5/2021, which modifies the revised text of the Capital Companies Law.

Iberclear launches a new service which facilitates issuers identifying the beneficial owners on their securities as well as participants and intermediaries on reporting this information.

Go-live will take place on June 7th. More information in Instructions 05/2021 and 07/2021, and in Iberclear's Private Area.

NEW PROXY VOTING SERVICE

Iberclear keeps working on the launch of an integrated and sustainable digital solution in order to connect Issuers and Participants in a centralised way to promote and speed up the voting process in General Shareholders' Meetings.

This new service will lead to manage Shareholders' Meetings in domestic and Cross-Border (CBS) securities, as well as foreign securities not held in Iberclear accounts.

SETTLEMENT DISCIPLINE

The 4th Informative Session on the Settlement Discipline Project took place on April 29th. The testing calendar was explained in it, including the certification annex and the modifications included in formats and procedures, in line with Instructions 06/2021 and 08/2021.

The aim is that participants are prepared and certified in time for the dry run scheduled for September, previous to the entry into force of this Regulation in February 1st, 2022.
