NEW LINKS BETWEEN THE CSDS OF SPAIN AND SWITZERLAND

As a result of the integration of BME into SIX, and expanding the settlement and custody infrastructures to funnel new transaction flows, the CSD links between Iberclear and its Swiss peer SIX SIS went in production along 2022. In this way, Iberclear offers its clients the possibility of settlement and custody of Swiss securities while on its side, SIX SIS also makes available to its clients the possibility of settlement and custody of Spanish securities. This feature will reduce costs and time for Iberclear participants as it simplifies the securities custody chain.

What happened lately

DLT BOND

Iberclear has completed the first issuance in Spain of a bond listed on a regulated market and registered for the first time using DLT technology. Issued by the Inter-American Development Bank (IDB) and with BBVA acting as the bookrunner and custodian, the first issue of these characteristics in Spain was completed in July, listed for trading on a regulated market (AIAF) and registered using blockchain technology. This platform may serve as the basis for future issues both in Spain and in Latin America.

On November 21, redemption for this first issue was successfully carried out.

REFORM OF THE SECURITIES MARKET LAW

The processing of the Securities Market Law, the draft of which was already submitted to public consultation in 2021, has continued its path in 2022 and at the close of these lines is in course of parliamentary discussion, with its approval expected at the beginning of 2023. Meanwhile, Iberclear has led the Reform 3 Technical Group in which the operational impacts of the discontinuation of the PTI proposed by the new regulations have been analysed.

On November 22, the "Report on the consolidation of proposals established in GTR3" was published in the private area of the Iberclear website, in the 'Propuestas e Iniciativas' section.
